Under section 33(2) (c) of the Income Tax Ordinance 1947, claims for exemption from Income Tax may be made on donations to school building funds.


Schools applying for exemption should submit to the Chief Education Officer, Education Office, Johore Bahru.

(b) the particulars in the attached form in triplicate.

On receiving these, two copies of each will be forwarded to the Director of Education for transmission to the Income Tax Authorities.
